- I, the undersigned, agree that I will not hold the Art League of Ocean City any of its volunteers, employees, or Board members responsible for any loss or damage, however caused, to any work submitted for exhibit.
- I understand the exhibition guidelines and that all artwork will be exhibited for the duration of the show. The last day of the exhibit is also the entry date for the next exhibit and at that time, all old work must be removed because the lack of storage space may result in damage. **Any work left for more than 3 months will become the property of the Art League** and will be disposed of in any manner decided upon by the Art League. Artwork may be retrieved by a person designated by me and made known to the Gallery Director or Gallery Assistant.
- I understand that the ALOC receives a commission of thirty percent (30%) of the sale price of artwork and all sales of artwork exhibited must be processed through the ALOC. If the sale price was discounted through an Art League member purchase discount, the artist will still receive 70% compensation as a percentage of the asking price. Payment will be made by check to the artist by the end of the month following the exhibit.
- I understand that all prices are established by the individual artists and are not negotiable by the Art League, its staff or gallery volunteers. If work is not for sale, I have marked "NFS" to indicate no sale price.
- I understand that the Art League reserves the right to judge whether or not a piece of art is original, is the work of the submitting artist, and if the work is appropriate for display in the OC Center for the Arts gallery.
- I understand that an unaltered image of my artwork may be used in publicity (print, web, and social media) with credit given to the artist.
- To comply with Federal tax laws, the Art League is required to issue a 1099 to any artist who sells more than \$600 in any calendar year. A W-9 Form will be provided by the Art League.
- I hereby accept all the conditions outlined in the exhibit guidelines and this entry form.
